What is SHINE?

S.H.I.N.E. – Start Helping Impacted Neighborhoods Everywhere – is a comprehensive initiative to clean up litter, debris & blight while assisting schools, parks & neighborhoods with projects that make a lasting improvement.

- ☆ County crews supervise participants who have been sentenced to community service.
- ☆ Judges can sentence directly to the SHINE. The judge will decide the hours and timeline participant has to complete. Can be utilized as a sanction or part of original probation.
- ☆ **SHINE IS NOW 7 DAYS A WEEK AND AVAILABLE AS AN ALTERNATIVE TO “WEEKEND JAIL”.**

What are the benefits?

Tax dollars are saved.

Keeps the jail population down.

Provides a positive avenue for participants to fulfill their sentencing requirements.

We have taken one less offender out of the justice system.

Citizens get to enjoy a real difference being made in their community.



What does a qualified participant look like?

- Nonviolent felony offenders who would normally be sentenced to incarceration in a state institution.
- Has not currently or previously been convicted of a sex crime which subjects him to registration under 57 O.S. State Statute 582.
- Please see included exclusionary list for SHINE.

Statutory authority that governs:

Oklahoma Statute, Title 22, Chapter 16, Section 991a-4.1 outlines the re-created “community Service Sentencing Program.” Section A. specifically lists that “the purpose of the program shall be to provide an alternative to incarceration for nonviolent felony offenders who would normally be sentenced to incarceration in a state institution.” Furthermore, B. 2 specifically states, “Has not previously been convicted of two or more felonies;” B.3 again states, “Has been convicted of a nonviolent felony offense which shall be defined as any felony offense except assault and battery with a dangerous weapon, aggravated assault and battery on a law officer, poisoning with intent to kill, shooting with intent to kill, assault with intent to kill, assault with intent to commit a felony, murder in the first degree, manslaughter in the first degree, kidnapping, burglary in the first degree.

Where do I go?

The participant will meet at McDonald's, 1004 W Sheridan Ave, Oklahoma City, OK 73106.

Park in the lower parking lot.

Option to ride in the county van, or follow in own vehicle.

This location was chosen as it is available to every bus route in Oklahoma City by that time.

Participation hours:

Monday- Friday 7 AM- 3:30 PM with a thirty minute lunch.

Saturday and Sunday 8 AM- 5 PM with an hour lunch.

Participants have the option to work a 4 hour day or 5 hours if working through lunch. (If one chooses this option, must provide own transportation).
