Polls will be open Tuesday, February 11, 2020 for voters from 7:00 a.m. to 7:00 p.m., but other voting options are available.

The Oklahoma County Election Board can accept absentee ballot applications from registered voters who want an absentee ballot mailed to them until 5:00 p.m. on Wednesday, February 5, 2020.

After the February 5 mail absentee ballot deadline, registered voters who want to vote absentee may still receive and cast a ballot by going to the County Election Board office located at 4201 N. Lincoln Boulevard in Oklahoma City on Thursday, February 6 or Friday, February 7 from 8 a.m. until 6 p.m.
