The feedback sandwich is a technique where you praise a little, then give the tougher feedback, and end with reassuring them what a great job they are doing. This method of feedback really doesn't work very well. Employees often find it to be confusing and possibly insincere. The employee may feel you are sending mixed messages, and as a result, what needed to be conveyed ends up diluted.

Feedback should be specific in your details, show them you care, and include the impact their performance is having on the organization or the team. This method of feedback is effective in praising or redirecting performance.

Feedback should be about giving, receiving, and redirection. Take turns taking the fall; it must never be about winning or losing.

Employees will work the extra hours, and do whatever it takes for a leader who will put his/her neck on the line first.

Take the lead in sharing your own human fallibility; put yourself on the line. Share what you are working on in your own personal and professional development.



## New Chief of Court Services





The Honorable Gregory Ryan, Special District Court Judge, departed from the Oklahoma County Juvenile Division and relocated to the Oklahoma County Courthouse, located downtown Oklahoma City, on Monday, July 22, 2019.

Judge Ryan, born in 1957, was raised in New York, New York. He graduated from Oklahoma City University (OCU) School of Law in 1982 with his Juris Doctorate and was admitted to the Oklahoma Bar Association the same year.

While an attorney, he was employed with the Oklahoma County District Attorney's Office (1982—1990), Abowitz, Welch & Rhodes (1990—1994), Able, Musser, Sokolosky, Mares, Burch, Kouri & George (1994—1996) and a founding partner of DeYong, Ryan & Rischard (1996—2001). His areas of practice included personal injury, medical negligence, administrative law, criminal defense, civil rights defense, criminal prosecution, domestic law, and juvenile law.

Judge Ryan was appointed as a Special Judge in July 2001; he served the Domestic Division from 2001—2005, the Criminal Division from 2005—2010, and the Juvenile Division from 2011—2019. Judge Ryan is married with four children, who have a passion for serving in the United States military. If you've ever spoken with Judge Ryan, you know his love of baseball and the Yankees. We are wishing Advocacy Supervisor Lola Hall well as she retires from CASA of Oklahoma County. Lola is a staple in the child welfare community and we will miss her insight, investigative prowess, and courtroom finesse. Her talents and wisdom have benefited the CASA program, our volunteers, and the incredible foster youth of our county for over two decades!

Our colleague Lola has had an incredibly storied life and career! Lola graduated from Classen High School in 1951 and received an English degree from Oklahoma City University. She began working at KWTW (Channel 9) in Oklahoma City in 1956. Often called "the Channel 9 Weather Girl," she was the first woman in the Southwest in that field of broadcasting. She also worked for other television and radio stations in the Oklahoma City area, including WKY-TV, KOKH-TV in sales and weather, OETA-TV in handicapped programming, KOMA-Radio in radio operations and traffic, and KTOK-Radio in sales and radio continuity. In New York City she worked for NBC as a program analyst.

Excelling in various broadcast responsibilities, Lola won the Oklahoma Education Association's award for Best TV Reporting in Education (1986), the Bill Crawford Memorial Award (1983), the Call for Action Award for Consumer Reporting (1978), and the Oklahoma City Mayor's Award for Handicapped Television Series (1976). Her special accomplishment was as a private consultant for Fortune 500 companies, developing video programs that distributed nationally and internationally. In 1988 she was inducted into the Oklahoma Journalism Hall of Fame. Near the turn of the twenty-first century, after thirty-seven years in radio and television broadcasting, Lola Hall served as director of the Women's Pavilion at Mercy Health Center, Oklahoma City.

And then Lola joined CASA of Oklahoma County in 1997. As an Advocacy Supervisor, Lola coached hundreds of volunteers as they investigated child welfare cases and made recommendations for the children they served. Lola was an outspoken voice for children's justice, suitable placements, foster home availability, and children's individualized needs.

CASA staff, volunteers, board, and others will miss Lola greatly. But we have learned so much from her over the years – her impact on foster care advocacy will resonate for a whole new generation of social workers and support staff. Thank you, Lola, for sharing your brilliance with us all!







A new whiskey distillery with a special place in American history will open its doors to the public in Tennessee in September. The company, called Uncle Nearest, honors the first known African American master distiller in the country: a slave who taught Jack Daniel how to make whiskey.

CBS News [first shared Nathan "Nearest" Green's story](#) almost two years ago in an interview with best-selling author Fawn Weaver. At the time, Weaver was devoted to uncovering and sharing Green's history. In the past three years, she's launched Uncle Nearest and has raised about \$20 million to take over the whiskey's production and turn a horse farm into a distillery.

The venture makes Weaver the first female and the first person of color to run a major whiskey or spirit brand. She said it's her way of honoring the man known to some as the "godfather of Tennessee whiskey."



Jeffrey Wright, from HBO's "Westworld," feels so passionately about preserving Green's story that he made a short film to honor him. "If you want to appreciate jazz, you better know who Louis Armstrong was," Wright said. "And if you want to appreciate American whiskey, you should know who Nathan Nearest Green was." In the late 1850's, Green — a farm owner's slave — started working with a young orphan named Jack Daniel. There's no known photograph of Green, but there is a photo of Daniel with Green's son, George, and other distillery workers from around 1900. It shows a black man and a white man sitting side by side at a deeply divided time in the American South.

"We just need to know stories like this because it smashes the lies," Wright said, later adding, "you have this... great iconic American brand, and... this thing that is representative of something that sits in our soul that's created by the coming together of two families... an unlikely partnership." That partnership was an open secret in Lynchburg, Tennessee, where William Hussey Jr. is a member of a Jack Daniel's fan club of sorts, the Tennessee Squires. He has a tattoo of the Jack Daniel's barrel house on his left arm — and on his right arm, he sports a tattoo of the Uncle Nearest logo.
